Working sessions will be held at the Slovak Philharmonic Hall Reduta. Conference venue will be divided into 3 zones:

- Delegation Zone with a meeting room and restricted VIP lounge area (for Delegates only);
- Zone for journalists and media representatives
- Zone for organization staff

Informal dinner will be hosted by Speaker of the National Council of the Slovak Republic H. E. Mr. Andrej Danko at Bratislava Castle (https://goo.gl/maps/F3ZLX4mx32z).

Arrival, departure and local transport

For Heads of Delegations (members of parliaments only) security and police escort will be provided by the Bureau for the Protection of Constitutional Officials and Diplomatic Missions (one limousine for each Head of Delegation). In case of their arrival/departure by car, the Bureau will also provide a police escort from and to the border crossing. The Presidency will provide a minibus (7 seats) for delegation members arriving or departing with their Head of Delegation, from and to the airport, including from/to the Vienna International Airport.

Delegations are kindly requested to inform the Presidency on the intended means of transport to be used when arriving to and departing from the Slovak Republic, as well as of the itinerary and place of arrival and departure (airport/border crossing, etc.).

Parking

Registration / Identification badges

For security reasons, access to official venues will be granted only to persons visibly wearing their identification badge.

All personal badges will display a photograph of the accredited person. Only good-quality ID format photographs showing a full face, without a head covering, in standard image file formats will be accepted. Badges will not be issued, if these requirements are not met.

Please, note that diplomatic representatives accredited to the Slovak Republic (including Ambassadors) have to be registered within the official Delegation to have access to meeting venues.

Colours of badges:

Lapel pin – Speaker/Head of delegation

Red – Member of Delegation with access to the Conference Hall

Blue – Member of Delegation with access to the Listening Room only

Grey - Organiser

Green – Security (without access to the Conference Hall)

Red – Interpreter (with access to the Conference Hall)

Lapel pins for Heads of Delegation and badges for Delegates will be distributed by Delegation's Liaison Officer on arrival.

Badges are personal and non-transferable and must be worn visibly at all times. The loss of a lapel pin or badge should be reported immediately to Delegation's Liaison Officer.

Format

Format of the Informal Meeting of Speakers of EU Parliaments is set as 1+4 (2 members of delegation with access to the Conference Hall, 2 members of delegation with access to the Listening Room only) + Security + Interpreter (if needed). Please note that Ambassadors and diplomatic representatives are included in the format already.

Liaison officers

A liaison officer will be assigned to assist each delegation for the duration of the meeting, i.e. from arrival to departure. Liaison officer will be in touch with respective country's Embassy in advance of the Informal Meeting.

Security instructions

All venues are accessible only to accredited persons wearing a valid badge.

Pins and badges must be worn visibly at all times. Weapons are not allowed in any of official venues. If a security officer wishes to carry a weapon on the territory of the Slovak Republic, a formal request must be submitted to the Protocol Department of the Ministry of Foreign and European Affairs of the Slovak Republic through established information channels.

If a radio frequency is needed, information on the frequency range and technical characteristics should also be communicated to the Protocol Department of the Ministry of Foreign and European Affairs of the Slovak Republic by the customary channels.

Due to capacity limits, the Head of Delegation may be accompanied by one Security Officer at official meeting venues. It is not possible to register more than one Security Officer per delegation. One Security Officer only will get a badge granting her/him the access to the venues.

Only accredited vehicles will be allowed to enter the security zones defined by the Slovak authorities. Embassy cars will not be included in the official motorcade. All security measures will be ensured by Slovak security forces at all venues during the program, including transportation from and to the airport.

Interpretation and languages of the meeting





Working languages of the meeting are Slovak, English and French. Heads of Delegations bringing their own interpreters may address participants of the meeting in any language of their choice. Simultaneous interpretation from/to Slovak, English and French will be provided by the Presidency.

Delegations willing to bring their own interpreters are kindly requested to inform organisers in advance. Number of additional interpretation facilities (booths) is limited and has been allocated **on a first-come first-served basis.**

Conduct of the meeting

Both discussion sessions will be presided over by Speaker of the National Council of the Slovak Republic, H. E. Mr. Andrej Danko. In the introductory part of each session there will be a place for short opening remarks of Heads of delegations interested.

Please inform the Presidency by Tuesday, 4 October, 3 pm. about the intention of a Head of Delegation to address the table with an opening remark. Order of respective speakers in the opening part of each session will be determined according to a time of registration of their interest to address an opening remark.

Please note that time of discussion sessions is limited to 90 and 120 minutes respectively and the main intention is an exchange of views of all participants in an open debate during each of discussion sessions, therefore time for opening remarks is limited.

Delegation facilities

A Delegates' Lounge Zone and a Delegates' working area will be available in Reduta, equipped with technical and IT facilities.

Wireless internet connection with unlimited access for Delegation members will be available in the conference venue.

Bilateral Meetings

For bilateral meetings, four bilateral meeting rooms with the capacity up to 12 persons will be available in Reduta. Delegations shall indicate their interest in bilateral meetings via their Liaison Officers.

Press and Media

All media representatives must be accredited for the Presidency. Journalists interested in accreditation to the Informal Meeting of Speakers of EU Parliaments are kindly requested to follow the instructions on the official web-page of the Slovak Presidency of the Council of the EU:

Media representatives are kindly asked to make their own travel arrangements and pick up their badges at the entrance of the Slovak Philharmonic Hall Reduta on Friday, 7 October.

Please note that media representatives will not have access to the Delegation Zone except for during the official media opportunities.
